Section II. Explanation

1. General Fund revenues have been increased for Interest Income due to the Federal Reserve increasing interest rates. The interest income comes from our capital management account. NC Sales Tax Refund income has been reduced as we are accruing this amount each month which makes the income overstated. Additional insurance proceeds were received for the year in the amount of \$490 that were not budgeted. The Town received \$40,027.81 in Hurricane Florence reimbursements from FEMA. Additional contract services expenditures have been budgeted to account for the cemetery upkeep and activity.
